WOOLSEY FIRE DESCRIPTION OF BURN AND POTENTIAL SEDIMENT IMPACT

Fire Name: Woolsey Fire
Date of Fire: November 9, 2018, to November 21, 2018
Burned Area: 96,949 acres
Location: Bell Canyon area, Cheeseboro Canyon Area, Santa Monica Mountains north of Malibu, and hillsides within the Cities of Calabasas, Agoura Hills, Westlake Village, Malibu, and Los Angeles. The burned area boundary is plotted on the maps in Attachment A.

Vegetation Types before Burn

California coastal sage, chaparral, with coastal sage scrub, and California montane chaparral and woodlands with chaparral and oak woodlands.

Fire History

The Woolsey Fire was the second largest wildfire to break out Los Angeles County in the past 100 years, with the largest being the Station Fire (160,577 acres) in 2009. The last major fire within the Woolsey Fire boundary in the Santa Monica mountains was the Corral Fire in 2007. Previously, there have been close to 100 fires recorded within the area in the last 100 years and 16 fires in the last 20 years.

Summary of Potential Postfire Debris Flow Impacts

The Woolsey Fire, divided into 14 regions as shown in the Burned Area Map, is primarily Debris Production Area (DPA) Zones 4, 6, and 7. Each region of the Woolsey Fire is subdivided into smaller subareas, which are subject to flooding and debris flow as shown in the Debris Flow Phase Map. The debris volumes noted herein are those resulting from a moderate to severe storm event. Below is a list of debris retaining structures potentially impacted.

Public Works reviewed and surveyed potential impacts to 2,957 residences below the burned canyons and hillsides of the cities of Agoura Hills, Calabasas, Malibu, Westlake Village, Los Angeles, and areas of Unincorporated Los Angeles County. Engineering advice was offered to 497 residents, 228 written advice and 269 verbal advice.
