The proposed Martin Luther King, Jr. Medical Campus (MLK MC) Clinical Laboratory and Red-Bag Storage Project consists of demolishing existing abandoned cooling towers at the MLK MC and construction of a 7,000 square feet single-story clinical laboratory, including a red-bag storage area adjacent to the proposed clinical laboratory.
