- 1) The facility is subject to Title 12, Chapter 12.80 of the Los Angeles County Code:

- 2) The Los Angeles County Code requires registration and inspections of specific commercial and industrial facilities within the unincorporated areas of Los Angeles County (except Antelope Valley, Santa Catalina and San Clemente islands) in order to annually certify that stormwater pollutant reduction and control measures are adequate, in place and are being maintained.
- 3) The business owner/operator shall complete and sign this application.
- 4) The owner/operator shall pay the Stormwater Registration and Annual Certificate Fee to the "Los Angeles County Public Works" by the due date or be subject to a penalty.
