HYDROLOGY, GRADING PLAN, AND LANDSCAPE PLAN REVIEW
(EFFECTIVE JULY 1, 2008)**

HYDROLOGY STUDY

Pursuant to Section 21.44.065 (1) of Title 21 of the County Code, fees are collected as follows:

Hydrology Study

(a) The fee for the first three plan reviews is as follows:

1 - 10 lots or commercials subdivisions with up to 30 parking spaces^	\$	2,838.00
11 - 30 lots or commercials subdivisions with 31 to 50 parking spaces^	\$	4,122.00
31 - 60 lots or commercials subdivisions with up to 70 parking spaces^	\$	5,513.00
61 - 100 lots or commercials subdivisions with up to 100 parking spaces^	\$	7,225.00
Over 100 lots or commercials subdivisions with more than 100 parking spaces^	\$	9,044.00

GRADING PLAN REVIEW

Pursuant to Section 21.44.065 (4) of Title 21 of the County Code, fees are collected as follows:

(a) The fee for the first five plan reviews is based on the estimated yardage:

1 - 10,000	\$ 6,993.00
10,001 - 100,000	\$ 6,993.00 + 13.75% of excess over 10,000 cu. yds.
100,001 - 500,000	\$ 19,441.00 + 3.90% of excess over 100,000 cu. yds.
500,001 - 1,000,000	\$ 34,850.00 + 2.87% of excess over 500,000 cu. yds.
1,000,001 and up	\$ 49,076.00 + 1.23% of excess over 1,000,000 cu. yds.

(b) After the fifth submittal - 10% of the original fee for each submittal.

(c) Revisions - Fee is based on \$ 130.00 per hour.

(d) A fee of \$ 345.00 to be applied to the fire department.

(e) A fee of \$ 453.00 if the project includes a Quimby park, and/or \$ 693.00 if the project includes a publicly dedicated trail, to be applied to the department of parks and recreation.

LANDSCAPE PLAN REVIEW

Pursuant to Section 21.44.065 (5) of Title 21 of the County Code, fees are collected as follows:

(a) The fee for the first three plan reviews is based on the estimated area to be landscaped:

7,501 to 15,000 sq. ft.	\$ 1,551.00
15,001 to 30,000 sq. ft.	\$ 1,666.00

Greater than one acre - Fee is based on \$ 130.00 per hour.

(b) After the third submittal - Fee is based on \$ 130.00 per hour.

(c) If the plans include a park, a fee to be applied to the department of parks and recreation, are as follows:

Private Park	\$ 671.00
Public Park, 5 acres or less	\$ 1,273.00
Public Park, between 5 and 10 acres	\$ 2,042.00
Public Park, greater than 10 acres	\$ 2,671.00

At the time of submittal, all applicants should submit the initial fee. For Grading Plan review all applicants should also submit earthwork calculations. The earthwork calculations will be reviewed during the checking process when the plans meet the conditions of subdivision approval and County standards. The balance of the fee, if any, will be due at that time.

(EFFECTIVE JULY 1, 2008)**

STORM DRAIN PLAN REVIEW (Miscellaneous Transfer Drain-MTD or Private Drain-PD)

Pursuant to Section 21.44.065 (2) of Title 21 of the County Code, fees are collected as follows:

(a) The fee for the first five plan reviews is based on the estimated construction cost as follows:

(d) Major revision - Fee is based on construction cost in accordance with table above.

STREET PLAN REVIEW

Pursuant to Section 21.44.070 of Title 21 of the County Code, fees are collected as follows:

(a) The fee for the first four plan reviews is based on the estimated construction cost as follows:

(b) After the fourth submittal - \$307.00 per sheet.

(c) Revisions - \$307.00 per sheet per submittal.

Pursuant to Section 16.10.100(C) of Title 16 of the County Code, fees are collected as follows:

Deposit of \$600.00 is required to review single lot grading encroachments (as part of referrals from Building & Safety)

At the time of submittal, all applicants should submit the initial fee and a cost estimate. The estimate will be reviewed during the checking process when the plans meet the conditions of subdivision approval and County standards. The balance of the fee, if any, will be due at that time.

SEWER PLAN REVIEW

Pursuant to Section 20.32.230 of Title 20 of the County Code, fees are collected as follows:

Estimated Construction Cost

(a) The fee for the first three plan reviews is based on the estimated construction cost as follows:

(b) After the third submittal - Fee is based on \$ 130.00 per hour

(c) Revisions - Fee is based on \$ 130.00 per hour

SEWER AREA STUDY

Pursuant to Section 20.32.250 of Title 20 of the County Code, fees are collected as follows:

Fee is based on \$ 130.00/hour with an initial deposit of \$ 1,000.00.

WATER PLAN REVIEW

Pursuant to Section 20.08.060 of Title 20 of the County Code, fees are collected as follows:

(a) The fee for the first three plan reviews is based on the Lineal Feet of Water Mains and/or Hydrant Laterals:

(b) Where the water system includes fire hydrants a fee, to be applied to the fire department, of \$ 182.00 for the first ten hydrants and \$ 31.00 per hydrant in excess of ten.

(c) The fee for Booster Pump Station, Reservoir, etc. is based on \$ 2,502.00 plus 0.17% of the estimated construction cost of the pump.

(d) Revisions - Fee is based on \$ 659.00 for each 1,000 ft. of the affected length of the Water Main Line.

Pursuant to Section 20.08.090 of Title 20 of the County Code, fees are collected as follows:

(a) Processing a certificate of registration or a water utility authorization \$ 462.00.

Pursuant to Section 20.08.091 of Title 20 of the County Code, fees are collected as follows:

(a) Water Appeals Board filing fee \$ 1,512.00 to be applied to the department of public works.

(b) Water Appeals Board filing fee \$ 126.00 to be applied to the fire department.

At the time of submittal, all applicants should submit the initial fee and a cost estimate. The estimate will be reviewed during the checking process when the plans meet the conditions of subdivision approval and County standards. The balance of the fee, if any, will be due at that time.
