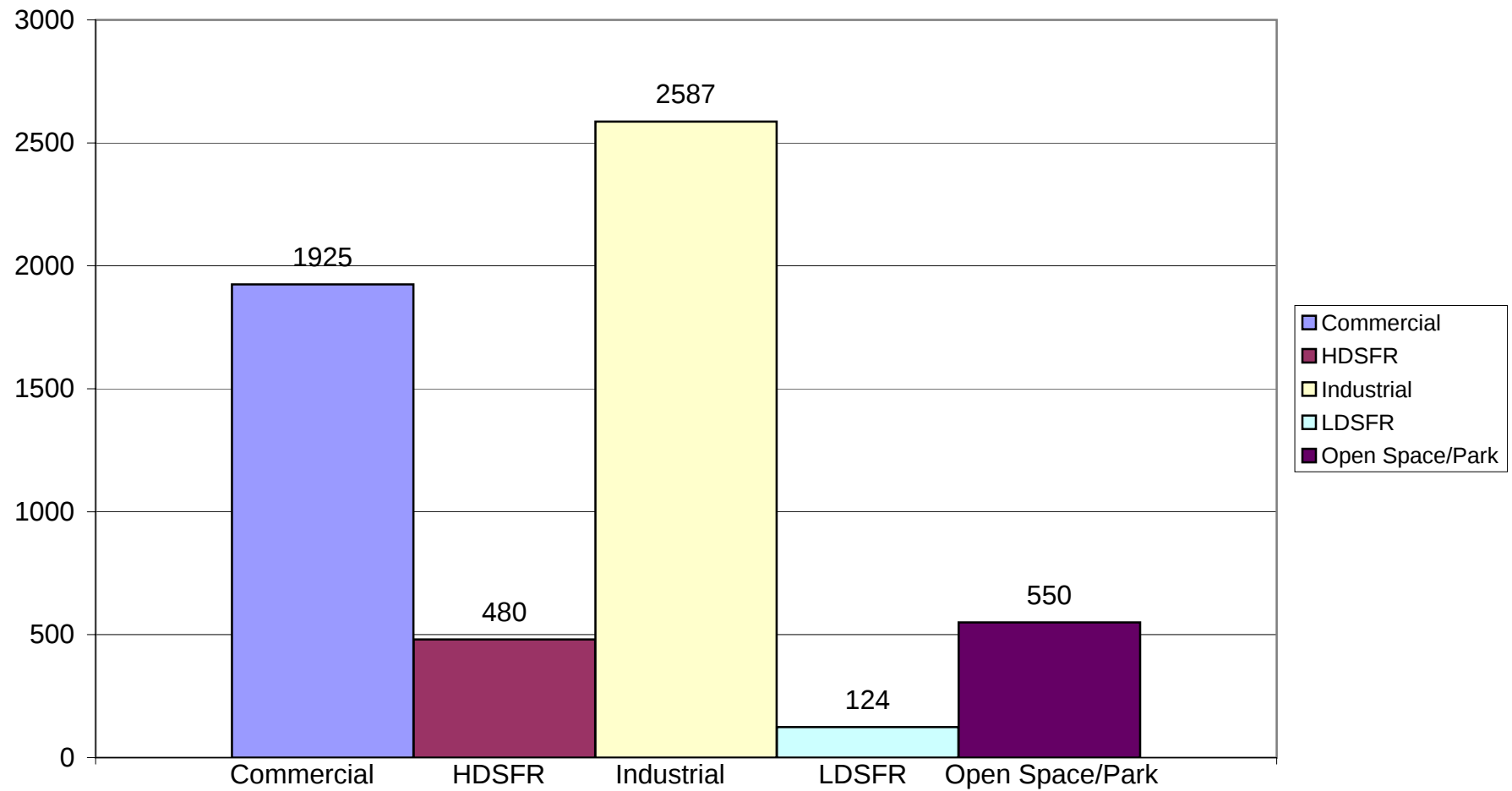

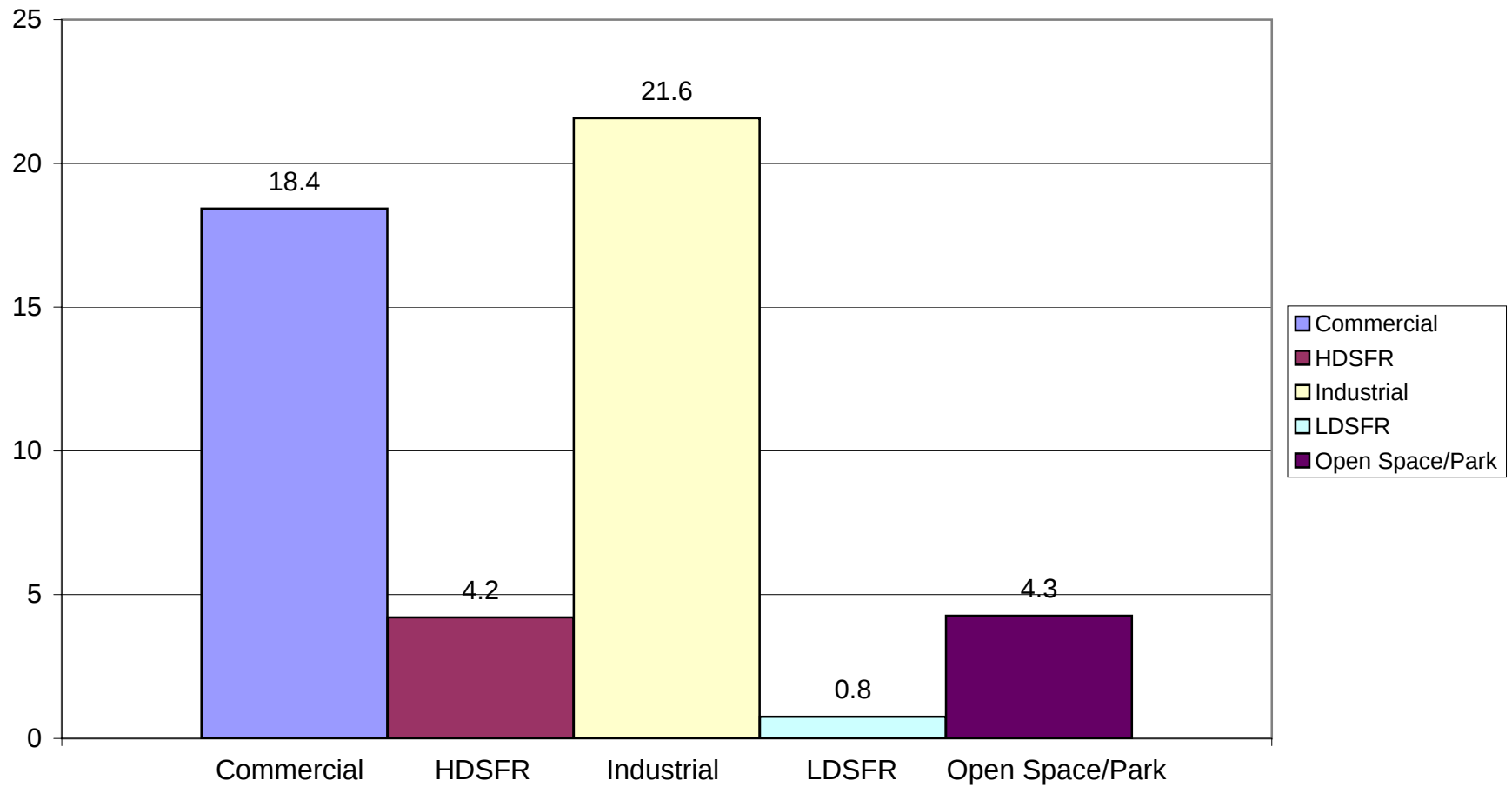

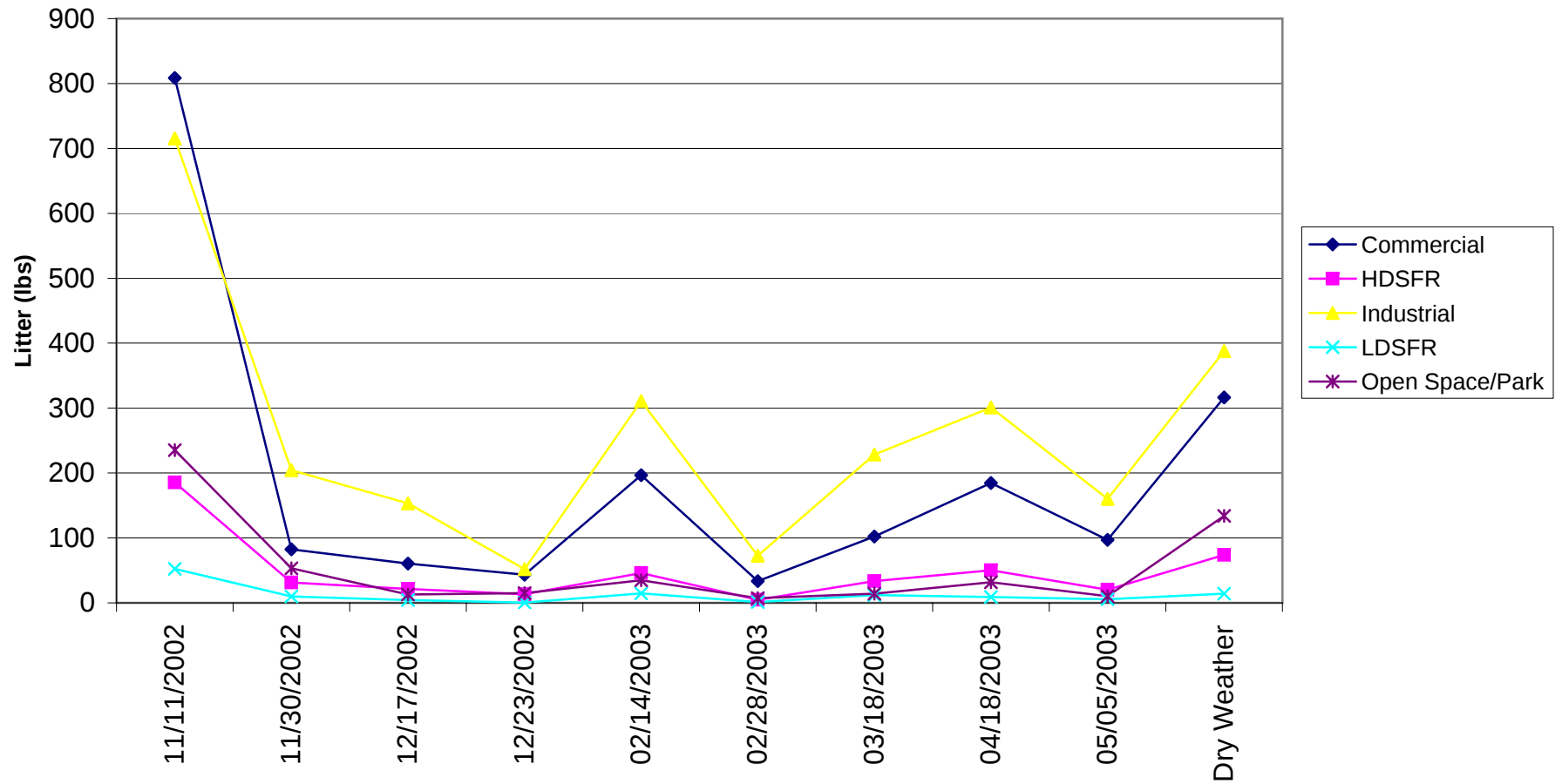

Litter/Clean-out

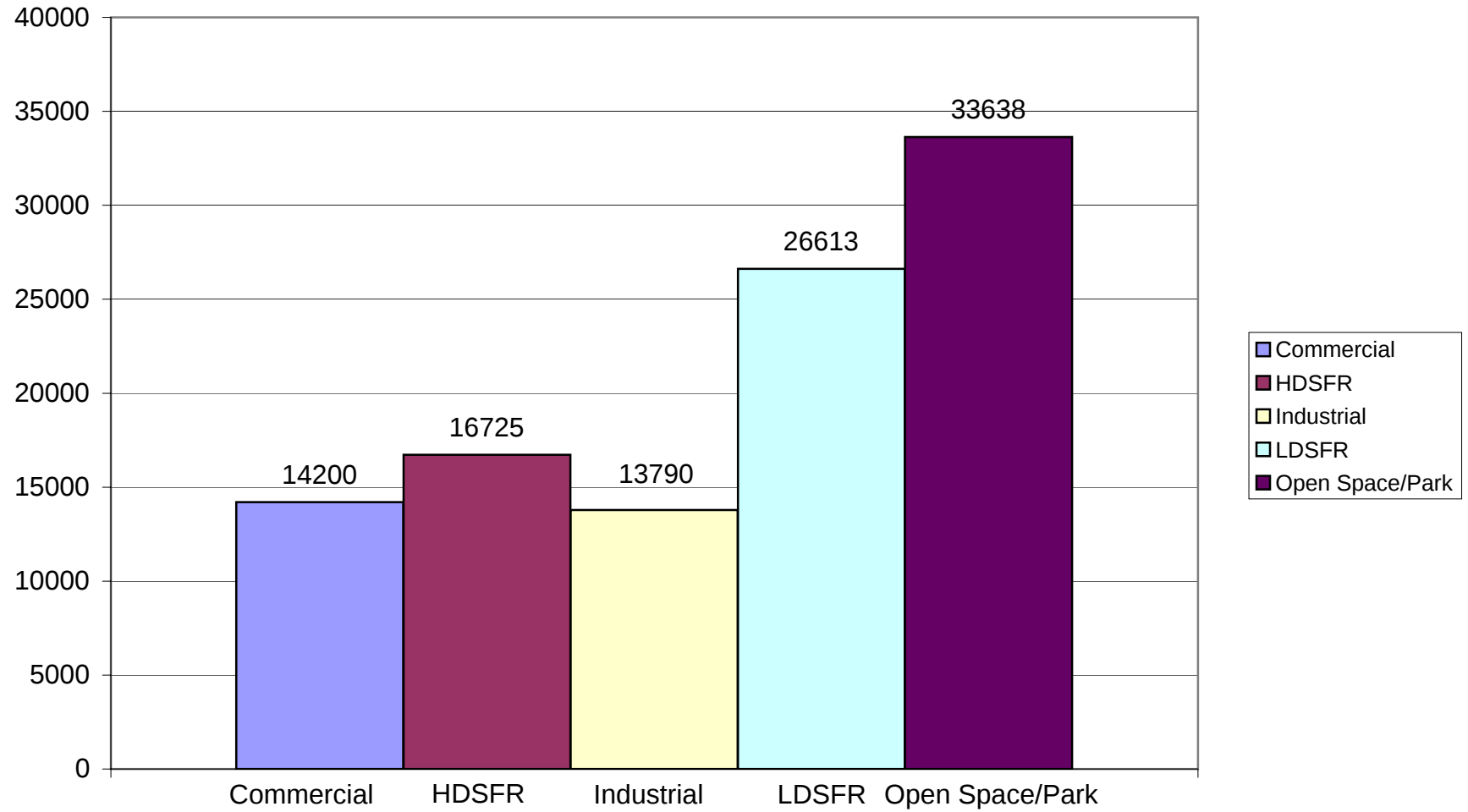

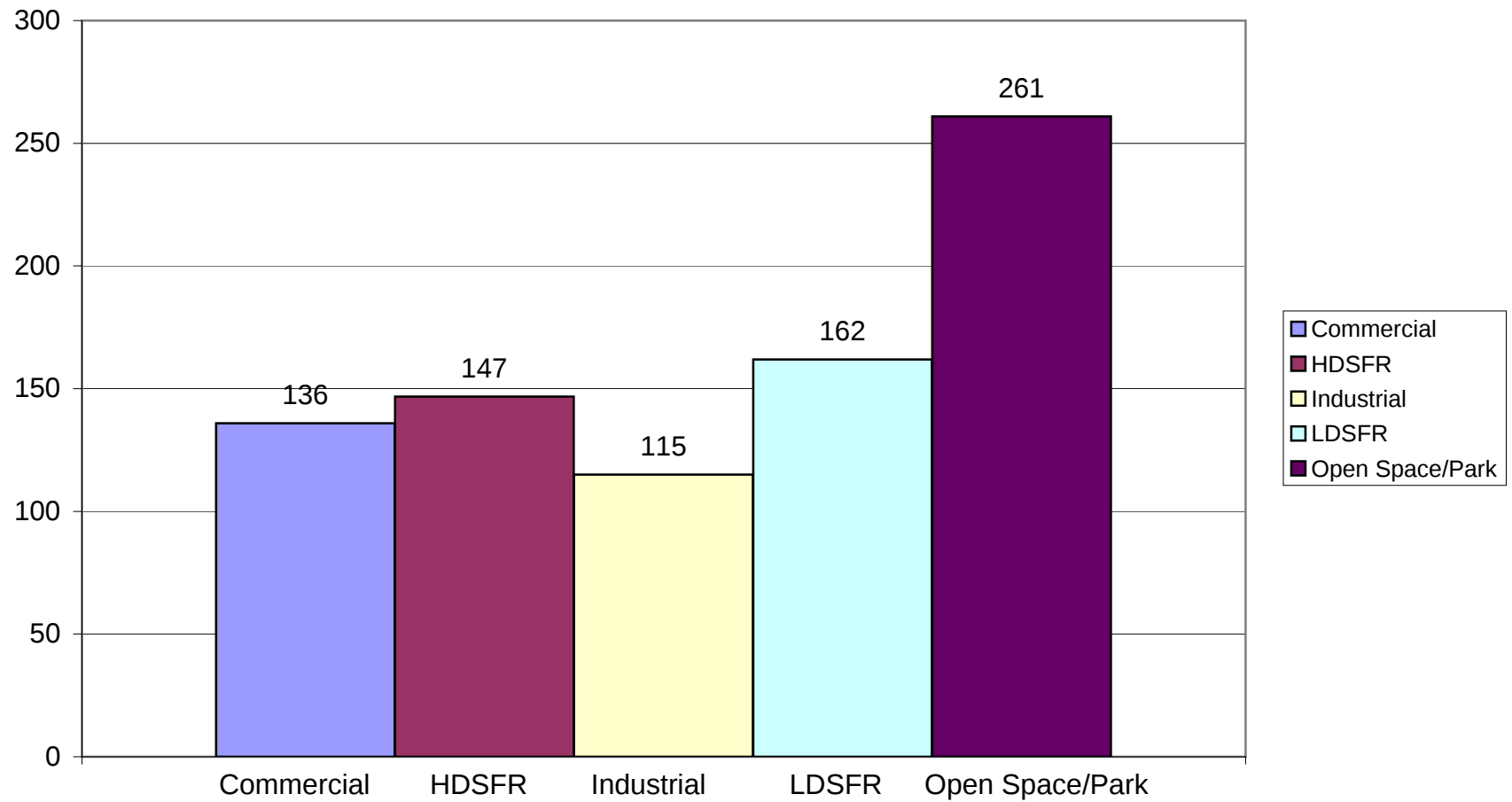

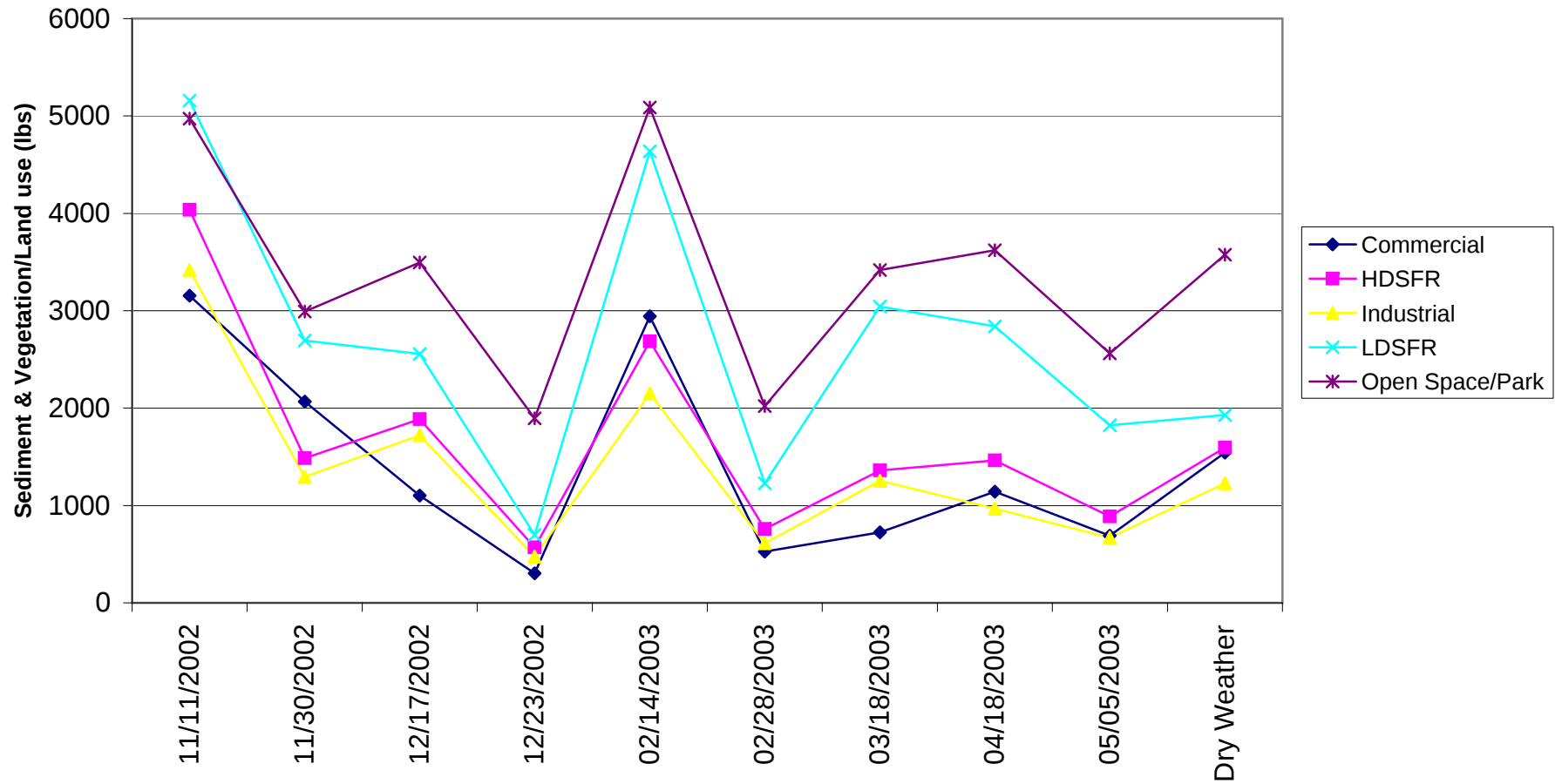
