ALLOCATION OF PROPOSITION 84 GRANT FUNDS

On behalf of the Greater Los Angeles County Integrated Regional Water Management (IRWM) region, thank you for your letter in response to our recommendation on how to allocate Proposition 84 funds.

We appreciate the differences in water resource issues and needs between the Ventura, Upper Santa Clara, and Greater Los Angeles IRWM regions. We also appreciate working with you to identify a methodology to allocate the Proposition 84 funds in a way that addresses the differences. However, after careful consideration of options, we still recommend that the allocation methodology be based on the initial funding precedent that established the allocations stated in the Proposition 84 bond, under which each recognized IRWM region within a funding area would receive a fixed-base allocation with the variable amount based on population within the established IRWM region.

We encourage you to provide a proposal that we can then compare and contrast to our recommendation. We look forward to your proposal and future discussions on the water resource issues and needs of the regions.
